Royal Assent announced to Tynwald – June 2020

AT 7 of 2020 **Children and Young Persons (Amendment) Act 2020**
AN ACT to amend the Children and Young Persons Act 2001 so as to provide for reviews in respect of the deaths of children and young people; and for connected purposes..
Signed in Tynwald: 5 June 2020
Received Royal Assent: 5 June 2020
Announced to Tynwald: 5 June 2020

Commencement: Sections 1 and 2 on passing; remainder by Appointed Day Order.
