Made: 29 June 2020

Explanatory Note: This Order brings the Children and Young Persons (Amendment) Act 2020 into operation on 24 July 2020. The Act makes provision for the review of the deaths of children and young people in the Island. The Act also makes consequential amendments to sections 8(4) and 9(1) of the Safeguarding Act 2018.
