Explanatory Note:	This Order brings into operation the Liquor Licensing and Public Entertainments Act 2021 (the “2021 Act”) in so far as it is not already in operation, save for section 18, and section 64(1) and Schedule 1 (to the extent that they repeal section 33(1) and section 75(1) of the Licensing Act 1995 (the “1995 Act”).
	This is subject to saving and transitional provisions.
