The following Appointed Day Order was laid at the March 2024 sitting of Tynwald.

SD 2024/0046 Justice Reform Act 2021 (Appointed Day) (No.2) Order 2024
 Tynwald Sitting March 2024
 Made: 19 February 2024
 Explanatory This Order brings into operation sections 4 and 5 of the Justice Reform Act 2021 on the day after the day on which this Order is made.
 Note: Sections 2(3), 88 to 102, 103(1), (2), (3), (6) and (7), 104 to 108 and 110 to 113 of the Justice Reform Act 2021 were brought into operation on 7 September 2022.
 Sections 1 and 2(1) and (2) of the Justice Reform Act 2021 came into operation on the Act's announcement day (20 July 2021).
 This order includes a transitional provision to the effect that the Criminal Justice Board's first general report to the Department shall be in respect of the period beginning with 1 April 2024 and ending on 31 March 2025 and must be submitted as soon as possible after 31 March 2025.
