AN ACT to amend the *Electricity Act* 1996; and for connected purposes.

PART 1 – INTRODUCTORY

1 Short title

The short title of this Act is the Electricity (Amendment) Act 2010.

PART 2 – AMENDMENTS

2 Amendment of the *Electricity Act* 1996

The Electricity Act 1996 is amended as follows.

- 3 [Amends section 2(7) of the *Electricity Act 1996* by omitting 'under this Act'.]
- 4 [Inserts sections 2A and 2B in the *Electricity Act* 1996.]
- 5 Section 3 amended (revenue of Authority to cover outgoings etc)
 - (1) Section 3 is amended as follows.
 - (2) [Amends section 3 of the *Electricity Act* 1996 by substituting subsection (1).]
 - (3) [Amends section 3 of the *Electricity Act* 1996 by inserting subsection (2A).]
 - (4) [Repeals section 6(1) of the Gas and Electricity Act 2003.]

6 Section 3A amended (accounts)

- (1) Section 3A is amended as follows.
- (2) [Amends section 3A(1) of the *Electricity Act* 1996 by substituting paragraph (b) for paragraphs (b) and (c).]
- (3) [Amends section 3A(1)(d) of the *Electricity Act 1996* by substituting 'the *Gas and Electricity Act 2003*' for 'that Act'.]

7 Section 3B amended (directions to transfer sums to General Revenue)¹

[Amends section 3B(1) of the Electricity Act 1996 by substituting 'any accounting year' for 'any year'.]

8 Section 3C amended (subsidiary companies etc)²

[Amends section 3C of the Electricity Act 1996 by inserting subsection (2A).]

9 Section 15A amended (power to lay gas pipes etc)³

[Amends section 15A of the Electricity Act 1996 by inserting subsections (6A) and (6B).]

10 Section 20 amended (interpretation)⁴

[Amends section 20(1) of the Electricity Act 1996 as follows: paragraph (a) inserts the definition of 'function'; and paragraph (b) adds in the definition of 'works' 'and, where the context requires, gas or telecommunications' after 'supply electricity'.]

PART 3 – SUPPLEMENTARY

11 Transitional provision

Where, in any of the accounting years ending prior to the year in which this Act came into operation, the revenue of any of the undertakings of the Manx Electricity Authority referred to in section 3A(1) of the *Electricity Act* 1996 was not sufficient to meet charges properly chargeable to revenue account, the Authority shall nevertheless be treated as having complied with section 3(1) of that Act.
