AN ACT to repeal spent enactments, and make minor amendments and corrections to Manx enactments; and for connected purposes.

BE IT ENACTED by the Queen's Most Excellent Majesty, by and with the advice and consent of the Council and Keys in Tynwald assembled, and by the authority of the same, as follows: —

PART 1 – INTRODUCTORY

The short title of this Act is the Statute Law Revision Act 2021.
