A MEASURE enacted pursuant to the *Church Legislation Procedure Act 1993* to extend to the Isle of Man the Safeguarding (Code of Practice) Measure 2021; and for connected purposes

1 Short title

The short title of this Measure is the Safeguarding (Code of Practice) Measure (Isle of Man) 2022.


2 Commencement

- (1) This Measure comes into operation on such day as the Bishop may by order appoint.¹
- (2) An order under subsection (1) may include such transitional provisions as appear to the Bishop to be necessary or expedient for the purposes of the order.

3 Extension of 2021 Measure to the Island

The Safeguarding (Code of Practice) Measure 2021 extends to the Island subject to the exceptions, adaptations and modifications specified in the Schedule.

4 Suspension of churchwarden

- (1) The *Churchwardens Measure (Isle of Man) 2013* is amended as follows.
- (2) In section 9A(1), after paragraph (b) insert –
| , or

- (c) the Bishop is satisfied that a churchwarden has failed to comply with a requirement imposed by the code under section 5A of the Safeguarding and Clergy Discipline Measure 2016. **22**.
- (3) In section 9A(5), after “(1)(b)” (in each place) insert **63** or (c) **22**.
- (4) In section 9B(3) and (4), after “9A(1)(b)” insert **63** or (c) **22**.

1. (1) In section 1(1), in the new section 5A —
 - (a) in subsection (2) —
 - (i) in paragraph (c), omit “, suffragan”;
 - (ii) omit paragraph (i);
 - (iii) for paragraph (k) substitute —

☐(k) any body corporate or unincorporate or committee established for the diocese of Sodor and Man, other than the diocesan synod or the standing committee of the diocesan synod; ☐;
 - (iv) in paragraph (l), for “section 80(1) of the Mission and Pastoral Measure 2011” substitute ☐ paragraph 1 of Schedule 6A to the *Mission and Pastoral Measure (Isle of Man) 2012* ☐;
 - (b) omit subsection (8);
 - (c) in subsection (9), for the words from “and section 6” onwards substitute —

☐ and section 6(4) to (6) applies to an order under this subsection as it applies to an order under section 6(3) ☐.
- (2) Omit section 1(2) and (3).

Amendments and repeals

2. (1) In section 2(1), for “Section 5(1) to (2A)” substitute ☐ Section 5(1), (2) and (4) ☐.
- (2) Omit section 2(5) and (6).

Short title, commencement and extent

3. Omit section 3(2) to (9).
