The Council of Ministers makes the following Order under section 2 of the Equality Act 2017¹.

Introduction

1 Title

This Order is the Equality Act 2017 (Appointed Day)(No. 1) Order 2017.

2 Interpretation

In this Order—

- (a) “the Act” means the Equality Act 2017;
- (b) “the first appointed day” means the day after the making of this Order;
- (c) “the second appointed day” means 1st January 2018;
- (d) a reference to a numbered section is a reference to the section of the Act so numbered;
- (e) a reference to a numbered Schedule is a reference to the Schedule to the Act so numbered; and
- (f) in articles 4 to 7 respectively a reference to a numbered paragraph is a reference to the paragraph so numbered in the Schedule commenced by that article.

3 Sections commenced on the first and second appointed days

- (1) Sections 166, 169 and 170 come into operation on the first appointed day to the extent necessary for the commencement of the provisions of Schedules 22 to 24 specified in articles 4 to 6 respectively.

- (2) Sections 166 comes into operation on the second appointed day to the extent necessary for the commencement of the provisions of Schedule 22 specified in article 7.

Provisions commencing on first appointed day

4 Provisions of Schedule 22 commenced on first appointed day

The provisions of Schedule 22 set out in column 1 of Table 1 come into operation on the first appointed day, subject to any exception, condition or limitation specified in column 2.

5 Provisions of Schedule 23 commenced on first appointed day

Paragraphs 1 to 3, 6 and 8 to 10 of Schedule 23 come into operation on the first appointed day.

6 Repeals commenced on first appointed day

Schedule 24 comes into operation on the first appointed day, other than the following provisions of paragraph 1—

- (a) subparagraph (c);
- (b) subparagraphs (f) to (i);
- (c) subparagraphs (k) to (m)(vii);

- (d) subparagraph (m)(ix); and
- (e) subparagraphs (n) and (o).

Provisions commencing on second appointed day

7 Provisions of Schedule 22 commenced on second appointed day

- (1) The provisions of Schedule 22 set out in column 1 in Table 2 come into operation on the second appointed day subject to any exception, condition or limitation specified in column 2.
